Resolutions & Recommendations Committee

National Bylaws

ARTICLE V

Section 1.6:

Resolutions are the Society's formal statement of philosophy or its deliberate choice of action and are effective for the next two years. Resolutions are looked to by the Society for organizational direction and by chapters for programming direction.

Conference recommendations are items suggested for the Society's leadership or chapters to consider.



Resolutions & Recommendations 2025

Whereas chapters maintain flexibility in their own membership processes,

Be it resolved that chapters have the opportunity to recruit and select junior standing collegiate students at their own discretion.

Whereas leadership continuity from year to year within chapters is critical,

Be it resolved that chapters are strongly encouraged to recruit and select junior standing collegiate students in addition to senior standing collegiate students.

Whereas new officers benefit from clear onboarding materials,

Be it resolved that the *National Office* produce simple and succinct videos and/or visual representation to:

- Welcome new officers to their roles and responsibilities;
- Provide an introductory overview of website resources for all new officers; and
- Provide an overview of the membership selections process.



(University of Tennessee, Knoxville, 1976)




Catherine Nelson Evans
