- **Spring deadline:** April 1

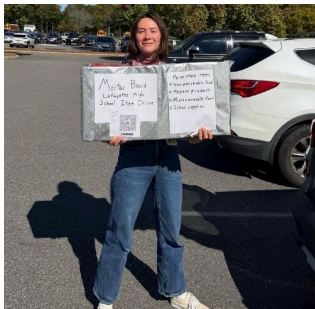
